By signing this agreement, I acknowledge that I will maintain a satisfactory knowledge of the rules and mechanics that govern USA Softball. Furthermore, I will carry out my game assignments in accordance to the rules of USA Softball and Got Game Fastpitch, INC.

The Coordinator shall hire the umpire as an independent contractor for a period of one (1) year 2018. The said Umpire agrees that he/she is an independent contractor with the Coordinator and not an employee

The Umpire agrees that he/she is obligated, at his/her own expense, to attend clinics, in-service training camps/evaluation tournaments, and further agrees that at such clinics or prior to the start of the season he/she shall register to qualify to work. The Coordinator by hiring the umpire is not required to and the umpire agrees that the Coordinator is not required to provide Umpire with any specific number of assignments for games during the course of this agreement. Any assignment(s) the umpire receives is subject to cancellation by the Coordinator or Director at his/her sole discretion.

The Umpire recognizing that umpiring softball games carries with it a certain assumption of risk of injury, hereby agrees that in the event of any injury, accident, or damage sustained by him/her as a result of any assignment(s) and/or injury, accident or damage sustained by any party to such assignment(s), the Umpire agrees to hold harmless the and the Coordinator/ Director of Umpires, and/or any and all staff of the tourney by the for any such injury, accident, and damage sustained.

The Umpire shall read and study USA Softball Rules and mechanics for the current year, and agrees to abide by the umpiring requisites contained herein, and any other requirements set forth by the Coordinator/ Director.

The Umpire hereby represents to that he/she is in good physical condition and has received a Physical Examination for Umpires prior to the start of the 2018 season representing that he/she is physically capable to umpire softball games throughout the 2018 season covered by the terms of this agreement.

Failure of the Umpire to abide by the rules and regulations set forth in this Agreement, and at the sole discretion of the Coordinator/ Director of Umpires may terminate this Agreement at its sole discretion at any time during the period of this Agreement.

This Agreement may be executed in any number of counterparts, any of which may be deemed the original.

No modification or wavier of any of the terms of this Agreement shall be invalid unless in writing and executed with the same formality as in this Agreement.

The failure of any party at any time to insist upon the strict performance of any of the terms or covenants of this Agreement shall not be deemed a waiver of the right to insist upon strict performance of the same or any other term or covenant of this Agreement at any time.

The Umpire hereby represents that he/she has not been convicted of a felony.

DECLARATION: I agree to serve as an Independent Contractor with respect to any assignment that I accept. I am solely responsible for myself. Further, I agree to hold GGF LLC and Tournament Directors harmless and free from any and all liability for injury or damage sustained as a result of any assignment. I agree to attend the clinics and take such qualifying tests and examinations as required. I understand and agree that this registration is for one year only, beginning on Jan 1st of this year (2018) and ending on last day of December 2018. Further, I understand that registration does not carry any obligation on the part of the GGF Director for a specific number of assignments. I also understand that the registration fee is nonrefundable. Any assignment that I receive is subject to cancellation by the GGF Director if he/she deems such cancellation to be in the best interest of the Organization. I also agree to keep the GGF Director fully informed of all closed dates and will accept assignments offered on those days I have indicated that I am available for assignment. By signing below, I certify that I have not been convicted of a felony. I further certify that if I am charged with a felony, I will notify Got Game Fastpitch LLC immediately.
